greetings to the woman: megan menke; who sometimes does act as clerk of district court; i hope you are well;

i, a woman: kimberly reicks; say it comes a time, when those of mankind, from a society not of i do trespass upon i, and so comes a time of i to simply be present as a woman in honor, to seek remedy to open a case at this court house to press a claim of trespass between i, a woman, and those of mankind whom i believe have done a trespass to i;

i, say: after many attempts to keep this matter private and to operate as a woman with rights; and to allow remedy;

i, say: with no remedy given; instead, only more trespass; so this has now lead i to require a room to press a court of record; to press claims of trespass; to be present as a woman before another man or woman who is competent at property and trespass law, they are to define the law; keep the peace; put forth the orders of the kimberly reicks court;

i, wish: to place as a claim on those i believe have trespass upon i and who have been sent notice of these trespass(s);

i, now give fair notice; i will be present simply as a woman to press claim; i will require a room to move this case through the court;

i, have chosen to be present before a court of record, under oath, there to testify with fact to support claim(s) of trespass since may 23, 2022;

i, require to remain a woman who does claim trespass;

i, say: any changes to this case will be seen as a trespass on this case; i will seek compensation by trial by jury in the amount of (\$10,000,000) ten million dollars each trespass; plus (\$10) ten dollars per second each trespass does continue as this would be a grievous trespass;

that said:

i, require no legal advice; i require no legal form(s) as i am no member of any bar guild association;

this is a claim, not a complaint;

that said, i wish with respect to require, megan menke, to act as clerk of the court;

1. i require megan menke to put forth a man or woman very well versed at law, i will simply need the man or woman to act as magistrate who is competent in property and trespass law; who will keep the peace; as i will be press this matter at a trial by jury as i press a claim; if no man or woman wishes to accept this duty, i will simply require this trial by jury to move and press before those of mankind;
2. file this claim with case and action number;
3. please time stamp and court stamp the original copy of this case and mail it back to the mail site i provide; please see pre stamped envelope within;
4. i require you to deliver a summon(s) to those of mankind that i have listed on page three of this claim by a man or woman who at times acts as sheriff;



however, i do believe that this is a public court for the use of man and woman, those of mankind to settle controversy matter(s) at a court of record under oath to testify to what is true without a fee; i will declare at this court to restore the right(s), property and seek compensation for the continue of trespass(s);

i, now call upon the man and woman; who at times does act as officer(s) of the kimberly reicks court to preform their duty with honor;

that being said; if court requires i will pay a fee in good faith because i require this case to move now to settle this case; i, will allow the court to restore the property and honor to i: the woman;

i, state here and will verify at open court before magistrate all to be true.
